We are pleased to invite you to submit your abstracts/papers for presentation at the 21st International Conference of MEEA, organized and hosted by Marmara University, Istanbul, Türkiye, on November 29–30, 2025. The conference will focus on various fields of economic research. This year's theme is:

“Transforming Economies: Energy Transition, Geopolitics in International Finance, and Sustainable Growth”

The conference will be held primarily in person; however, an online option will be available, with priority given to international participants. The sessions will include a mix of regular and invited sessions.

The global economy is undergoing an unprecedented transformation, driven by the rise of energy transition and shifting geopolitical dynamics. These profound changes are reshaping the landscape of international finance. The MENA region also plays a crucial role in this transition, given its dominant position in global energy markets, its geopolitical significance, and its ongoing economic diversification efforts. - Each submission must include JEL classification codes and up to three keywords.
- Authors will be notified of acceptance by **June 23, 2025**.
- General registration fee: \$50. Student registration fee: \$10 (to encourage participation from young researchers).
 - For Turkish participants, general registration fee is 1500 TL, graduate student registration fee: 500 TL.
